- **Payment of \$5 fee per vehicle being registered.**
- **Verification of Residency/Taxpayer Status (such as tax or utility bill)**

The **TEAL** parking sticker is valid **through September 30, 2019**. It allows residents and/or taxpayers to park in the parking spaces throughout Oak Island labeled "Resident Parking Only" when affixed to the inside front driver's side lower corner of the windshield.

These stickers are **ONLY** for parking in the Town's "Resident Only" reserved spaces. They **are not** used for post-storm reentry. Post storm entry will require a recent tax or water bill **and** a valid driver's license (for non-resident property owners; residents may use a valid driver's license that shows an Oak Island address).
